

Image use policy

The Jewish Museum of Australia aims to make its collection easily accessible to users, whilst protecting the copyright and intellectual property rights of content producers. It is your responsibility to understand and comply with this Image use policy before using materials from our collection.

All images, audio and audio-visual material and associated digital files are owned or licensed by the Jewish Museum of Australia and protected by a Creative Commons Attribution-NonCommercial-No-Derivatives 4.0 International licence. Images, audio and audio-visual material and associated digital files are hereinafter referred to as licensed materials.

Under the terms of this licence, users may download, store or display unaltered copies of licensed material for personal, research or other non-commercial use. If you distribute or display licensed materials belonging to the Jewish Museum of Australia you must attribute the Museum as the source. You do not have permission to adapt licensed material without permission of the Museum.

Third party copyright

The Jewish Museum of Australia does not own the copyright or reproduction rights to all materials in the collection. Some images, audio and audio-visual material and associated digital files are the property of third parties. Where copyright is not owned by the Museum, the Museum can facilitate reproduction applications to third party copyright owners.

Take down notice

Every reasonable effort will be made to contact and acknowledge copyright holders for the purposes of publication by the Museum. Any copyright holder who has not been properly identified should contact the Jewish Museum of Australia for correction.

Public domain

This licence does not apply to works in the public domain. A work may be in the public domain if the duration of copyright has expired or the material has been made available by the copyright owner. Note that a work may be in the public domain under the copyright laws of one jurisdiction but not another, according to



its place and date of production and type of work. For more information on what constitutes a public domain image in Australia, please refer to the Australian Copyright Act 1968. Image reproduction requests

If you plan to adapt, publish or redistribute licensed material, including materials owned by the Museum and materials licensed from third parties, for purposes other than research or personal use, you must gain written permission from the Jewish Museum of Australia. To gain this permission, please complete the application at the end of this policy and send to our Registration Officer at L.McAlary@jewishmuseum.com.au.

Each request will be assessed on a case-by case basis and may be granted at the discretion of the Jewish Museum of Australia. The Museum reserves the right to charge for the commercial use of its material according to the character and extent of the intended use.

Terms of agreement

If approved, this agreement specifies that the Jewish Museum of Australia gives permission for the reproduction of the materials, named above for the intended use, described above. The signatory party must comply with the following conditions of this agreement:

- This agreement is for single use only and does not grant the signatory party exclusive and continued use of Museum material. Any subsequent use of Museum material will require additional permission.
- The material must be reproduced as an unaltered copy of the original work or image. The material must not be remixed, transformed or cropped without the express permission of the Jewish Museum of Australia.
- The copyright holder should be acknowledged where possible. The Museum will advise correct attribution of the copyright holder.

By signing this declaration, you confirm that you have read and understand the terms of this agreement and agree to abide by these terms in the event that your application is approved.
