

Image Use Policy

The Jewish Museum of Australia aims to make its collection easily accessible to users, whilst protecting the copyright and intellectual property rights of content producers. All images, audio and audio-visual material within the collection are owned by the Jewish Museum of Australia. If you wish to adapt, publish or redistribute licensed material, you must gain written permission from the Jewish Museum of Australia. To gain this permission, please download the Application to Reproduce Images form and send the completed form to our Curatorial Team at curator@jewishmuseum.com.au

Each request will be assessed on a case-by case basis and may be granted at the discretion of the Jewish Museum of Australia.

Copyright permission

The Jewish Museum of Australia does not own the copyright or reproduction rights to all materials in the collection. Where copyright is not owned by the Museum, the requestor(s) will need to secure permission from the copyright holders. Evidence that permission has been granted by the copyright holders must be forwarded to the Curatorial Team.

Any copyright fees requested by copyright holders are the responsibility of the applicant and are additional to the Museum's fees for the supply and reproduction of images. The Jewish Museum of Australia accepts no responsibility for images reproduced without the copyright holder's permission.

Moral rights

The Jewish Museum of Australia will provide appropriate acknowledgment and credits, which must be accompanied with the reproduced material. Reproductions must also show due consideration for the artist's reputation and the integrity of the work of art. Failure to meet these requirements may constitute infringement of an artist's moral rights. Fees

The Jewish Museum of Australia may charge a fee for providing reproduction of images. If a fee is charged, an invoice will be issued and must be paid in full before image material is dispatched to the applicant.

Delivery times

The Jewish Museum of Australia endeavours to supply image material in a timely manner to meet the applicant's deadline. The following conditions must be taken into account when placing an order for image material:

Image requests can take up to 4 weeks to complete. Delivery time may take longer if more than 5 images are requested in one request.

Publishers are strongly advised to allow sufficient time in their publication schedules for the checking and approval of proof prints.
